### Bublitz's Breakfast Meeting 9:30

1. Welcome & Introductions
2. Treasurer's Report
  - a. CD - \$13,393.41
  - b. Checking - \$7,791.72
  - c. check for the show \$4,231.57 (split)
    - i. Should NEWQHA pay for 1/2 of the bill for painting the trail and jump equipment? Total was \$216.32
    - ii. received a check from Cap Gun for Trail Equipment Rental. Who gets that check? WAQHA or NEWQHA
      1. Club agreed that all expenses and income should go into combined show account to keep track
      2. Club believes that all equipment is co-owned 50/50
        - a. Jumps were purchased/owned by both
        - b. Trail equipment-some was owned by both and then additional polls purchased by joint show committee
3. Secretary's Report-Reviewed minutes from Jefferson and highlights from previous show meetings
4. Discussed potentially working on mission statement into future
  - a. Ideas were Camaraderie, Social/fun at shows, support amateur exhibitors, promote WQHA and growth of WQHA through the amateur division, promote engagement with AQHA horses

  - b. Discussion over jumping. WI trainer reports that having open/non-aqha would increase draw for jumpers to come. Discussed starting show early so jumps could be set overnight. Discussed having that trainer cover \$ in case those he guarantees do not show up.
