
Stephanie Hicken made a motion to accept the treasurer's report. Jessica Bradley second it. Motion carries.

State Show Comments: Need to recognize contestants thru announcements, trophies and ribbons. Dusty arena footing got worse as the show went on.

Slots & Non-pro Challenge comments: Liked slots all in one night. Replace slots with breeders' futurity.

Midwest Horse Fair Booth: Should keep booth, reach out to members to fill spots.

Need more interactive activities. Could include raffles during the event of lessons,
clothing, etc. If trainers are willing to donate their time, their pictures and bios could go up
in the booth and any social media we have. People who volunteered to help: Liza Zurn,
Gail Peteler, Jim Mckillips, Tina Bothum and Linda Berg

Proposed Bylaw addition regarding membership requirement: Passed unanimously.

Feedback on adding Green (level 1) Equitation, Horsemanship, and Showmanship: Could reduce numbers in regular classes that often struggle to get 3 horses without combining.

Could add to length of show (every year we seem to be adding more classes)

Might encourage people to try a new class.

Consensus of Group: Try one class next year - Showmanship - and check interest.

Feedback on Small Fry Change to AQHA approved classes: Because of the additional expense of \$10/judge for an AQHA class, keep Small Fry as WQHA 10 and under class.

Districts 5 & 6 used to run The Fuzzy Wuzzy shows and donated proceeds to the WQHA. The show account has a balance of \$5,247.65. The district members would like to donate \$500 to the WQHA award program this year due to the decline in entries at 2024 Wisconsin approved shows. Furthermore, the member would like to have the WQHA act as custodian for the remainder of the money if possible. Suggested having a line item in the financial statement with a footnote that Districts 5 & 6 members had to approve any expenditures.

Members suggested holding a clinic using the Wisconsin Professional horsemen...

Could include write ups of the trainers to give them more exposure on social media. May have a place in Oregon, WI. Pat Miller following up on the idea.

Amateur Ambassador - Amateur Ambassador Roll Out 2024

Goals of the AQHA Amateur Ambassador Program

The goal of the AQHA Amateur Ambassador Program is to identify amateur liaisons, to

serve as welcoming ambassadors at horse shows, who can provide helpful and essential information to all attendees. AQHA Amateur Ambassadors are to be friendly, available and approachable connections that provide that ALL IMPORTANT FACE TO FACE

resource for answering questions and providing information to exhibitors.

Amateur Ambassadors are NEVER TO PROVIDE ANY TRAINING INFORMATION,

which for the purposes of the Amateur Ambassador program include pattern interpretation, legality of equipment, rule interpretation, etc. Any questions should be directed to

Stewards, Professional Horsemen, or trainers for clarification. Amateur Ambassadors should encourage exhibitors to use the AQHA App on their phones or their AQHA Rule Books.

AQHA Amateur Ambassadors are expected to conduct themselves in a manner that reflects professionalism and good character. They are representing themselves, their Affiliate and AQHA.

Amateur Ambassadors are encouraged to communicate with AQHA staff with regards to feedback to improve the Program.

How to Become an Amateur Ambassador

Interested individuals must be an AQHA Amateur Member and an Affiliate Member.

Future prospective Ambassadors can be members of any Affiliate, especially if they show more in another state. Ambassadors may serve at shows in other states.

Interested individuals should reach out to the amateur.ambassador@aqha.org email.

They will then receive an Invitation Letter that explains the program and the application

process (including the need to identify an approving individual from the Affiliate) with attachments of the Roll Out Document as well as a sample Code of Ethics. To proceed,

request from the amateur.ambassador@aqha.org email an Adobe Docusign version of the Code of Ethics. Once completed, return to the same email. AQHA will then review.

When approved, an Approval Letter will be sent with information on how to sign up for shows on a Google Doc and a link for the Post Show Summary Report.

An approved individual will serve as an Amateur Ambassador for the remainder of the calendar year in which they are approved. If they elect to continue in the program, and AQHA agrees to the same, the individual will need to re-sign the Code of Ethics for the next calendar year.

Amateur Ambassadors will receive information on the goals of the program, suggested pre-show activities, and expectations at horse shows. (See below)

Amateur Ambassadors may serve at horse shows that are not in their state, if they are familiar with the show, the exhibitors, the location, and show management, so as to be

the best resource for exhibitors. Unless indicated otherwise, service at an AQHAapproved event does not require pre-approval from AQHA. EXCEPTION: Service at any AQHA Championship event does require pre-approval and a request should be sent to Melynda Regester at least thirty (30) days in advance. Responsibilities and acceptable

Ambassador activities at AQHA Championship shows may vary from other AQHA-approved events. Service at a non AQHA-approved event also requires pre-approval from

AQHA and a request should be sent to Melynda Regester at least thirty (30) days in advance. At AQHA's only discretion, the thirty-day requirement can be waived.

Amateur Ambassadors will need to obtain prior approval from Show Sponsors to serve at their show, and will notify Show Management that they will be at the show, prior to the show date. A Google Doc accessible to Amateur Ambassadors will allow for show sign up and will allow Ambassadors to indicate whether Show Sponsors have approved and Show Management has been notified. The Google Doc will also allow an Amateur

Ambassador to see if others are also interested in serving at that show. A list of Amateur Ambassadors can be provided to Show Managers and Show Sponsors. Melynda

will be the resource for Show Sponsor contact information.

AQHA Amateur Ambassadors will be provided with an identifying lanyard with AQHA Amateur Ambassador badge. This is an AQHA Program!!

As our committee works with the AQHA Marketing Department and Corporate Sponsors, additional Amateur Ambassador apparel and items may be provided.

There will be information about the AQHA Amateur Ambassador Program disseminated

by the AQHA Marketing Department. Additionally, other avenues to introduce the program are being investigated.

At the conclusion of each Amateur Ambassador's service at an event, he or she will

complete a Post Show Summary to provide feedback about the effectiveness of the program and feedback. This information will be useful for determining the impact of the program and keeping it current. Any other concerns should be brought to AQHA.

Amateur Ambassador's Role Prior to the Show

Create social media posts (Affiliate websites, Facebook,other) introducing yourself as

the AQHA Amateur Ambassador at the show. By notifying/contacting Show Management prior to the show, obtain permission for sharing the show information (patterns).

But remember, we are sharing information, not creating show promotion.

May elect to utilize tools such as Padlet, an online bulletin board, for showcasing show information, showbills, Judges, patterns, AQHA and Affiliate membership information, local restaurants, hotels, grocery stores, feed stores, veterinary care, urgent care, truck repair, hardware stores, etc. A QR code can be generated to also create flyers to post around showgrounds containing all of this information.

Amateur Ambassador's Role at the Horse Show

Introduce yourself to show management, show secretary, Stewards, Professional

Horsemen, and Judges (if you are comfortable) This is a a courtesy to let them know you are present and available for assistance.

Attend any pre-show meetings for exhibitors, if possible, to be aware of any changes.

Utilize a whiteboard in the show office. Information on how you can be contacted can be provided. Post the Stewards and on-site Professional Horseman if they have agreed to

be resources for questions. The Judges can be listed. Any generated QR codes containing Padlet information can also be showcased here.

If possible, obtain a list of new exhibitors-new to AQHA, to the Affiliate, to this show, to showing in general, to target for welcoming.

Be available to exhibitors. Share the enthusiasm we all have for our American Quarter Horses!

WQHA Paid Positions -

Treasurer: \$1,200.00 per year.

Points and Memberships: \$2,750.00 per year.

Editor: \$2,500.00 per year.

Jessica Bradley makes a motion to accept these paid positions for 2025. Alec Martin second it. Motion carries.

Show and Contest Changes - WQHA approved adding the 3 non-pro classes, Horsemanship, Showmanship, and Equitation. WQHA small fry stays 10 and under and will not have the additional AQHA approval. Travis Born makes a motion to add Non-Pro Level One Horsemanship, Showmanship, and Equitation to the slate of classes. Nikki Schultz second it. Motion carries. Jessica Bradley makes a motion to change verbiage in show and contest rules from under 10 judges to at least 10 judges. Linda Berg second it. Motion carries.

Awards - Budget is \$12,700.00 from \$1 fees. District 5 & 6 donated \$500.00 and Wisconsin Horse Council also donated \$500.00. Award letters have not been sent yet. Once they are sent a due date will be given. 11/6/2024 is not the due date. Tim Schmahl makes a motion, as we designate someone who doesn't show to at least 10 judges or meet the 20 point requirement will receive WQHA show bucks to be used at the WQHA State Show. Grand will receive \$20.00 and Reserve will be \$10.00. With no vendor choices. Ron Miller second it. Motion carries. Travis Born opposes.

Banquet - LaSure's prices change every year at the new year. Please complete the survey that will be sent out with award letters.

Hall of Fame - Meeting is scheduled for 11/9/2024 at Jessica Bradley's home.

Midwest Horse Fair - Liability insurance needs to be renewed. Ron Miller will contact Kathy Doyle to ensure this. Missy Baker will chair a committee to plan Midwest Horse Fair and bring back information to the board to approve.

Memberships - 2 members from Colorado, otherwise no changes.

Newsletter & Directory - Missy Baker and Jessica Bradley will help contact people for advertisements.

Open Show - N/A

Scholarship - No applications received. Jessica Bradley makes a motion to use the silent auction money from the WQHA banquet towards awards for the subsequent year. Missy Baker second it. Motion carries. Pat Miller makes a motion to earmark the current amount in the WQHA scholarship fund, and can only be used in a financial emergency for other reasons. Jessica Bradley second it. Motion carries. Linda Berg opposes.

The board is deferring to the scholarship committee for the criteria of approval.

State Show & Slots - State show and slots made about \$22,000.00 in 2024.

Travis Born makes a motion to defer to the State show committee to bring 3 options for locations of the 2025 State show by January 19, 2025 or we don't have the show. Stephanie Hicken second this. Motion carries.

Recreational Activities - Trail ride was great. Maybe setup times for some trail rides going forward. Great exposure for WQHA. Great to see some old faces. Tentatively, have the second annual trail ride October 3rd - 5th, 2025.

Travis Born makes a motion to raffle off a donated gun at the 2025 banquet. Jessica Bradley second it. Motion carries. Judy Zeitler will donate the gun.

Board members are expected to donate an item to the silent auction at the 2025 banquet.
